2. Normal depth of Stand Space will be 9 meters. (To include parking of Vehicle)
3. Stands are limited in number and cannot be guaranteed. They will be situated in proximity to the Show Rings & other attractions at the discretion of the Committee.
4. There is **NO ELECTRICITY** on the show field.
5. Closing date 1st July 2025. A Vehicle Pass, together with an Acknowledgement slip showing Stand Number, will be forwarded at the beginning of August 2025. Extra personnel, other than authorized, must pay the normal admission charge. Vehicle Pass must be displayed on Vehicle.
6. A Trophy will be awarded for the Best Presented Stand (to be kept for 1 year).
7. No Raffle Tickets to be sold on Show Day.
8. Please leave any rubbish neatly on your stand (black rubbish bags will be provided).
